LMRA Meeting Minutes: 9 September 2009

Current Issues

- Issue: **Neighborhood Watch**
Status: Herb Daniels provided an update on the program.
Update: A Halloween safety "Spooktacular" will be held on October 31st to promote the neighborhood watch and kick off the program for the La Mesa community.

- Issue: **Trash Can Storage on Wilkes LN**
Status: A resident has requested help from Pinnacle in getting residents of Wilkes LN to store their trash cans in designated areas. The cans were being left at the end of the street, which invites rodents and contributes to litter.
Update: The trash cans have been moved. This matter is closed.

- Issue: **Field Conditions and Watering**
Status: Residents requested repairs and a reduction in watering.
Update: The Spruance field will be reseeded and leveled at the end of October.

- Issue: **Community Center Weekend Reservations**
Status: Residents requested a modification to the reservation process to allow multiple groups to share a weekend.
Update: The policy is at the JAG awaiting approval in the next month.

- Issue: **Status on request to create a lemon lot**
Status: A resident asked if it would be feasible to set up a lemon lot on in La Mesa due to the high turnover of residents.
Update: Request was denied due to lack of available space.

- Issue: **Status on request for a smart pole in Terrace Oaks**
Status: A request has been submitted by the Terrace Oaks neighborhood representative for a speed monitoring smart pole to be placed on Spruance in Terrace Oaks.
Update: The smart poles were approved in the POMPD budget but they have not arrived yet due to contracting difficulties.

3. Partner Updates:

POM Police Update

- The POMPD has received speed bumps to be placed in LMV at locations specified by the LMRA.
- The Home alone policy is posted on the LMRA website.

Pinnacle Update

- Pinnacle has a new Military Housing Office that will be used to advise incoming service members of their housing options upon arrival at DLI or NPS.

4. Other New Issues

- Issue: **Emergency Vehicle Driving in La Mesa**
Clarification on when emergency vehicles use lights only or lights and sirens when going through La Mesa.
Status: The sirens should be on unless they are responding to a crime in progress or domestic dispute.
- Issue: **Community Center after-hours access**
Status: Pinnacle is working on a policy change for after-hours access. The access code may be changed as well but the residents need to be vigilant and not disclose the code to people who do not live in LMV.
- Issue: **Non-use of bulletin boards for advertising important events**
The bulletin boards were not used to advertise the Town Hall meeting in August, the car wash, or September's movie night.
Status: The bulletin boards will be updated.
- Issue: **LMRA Membership and Organizational changes**
Farewell to Erik Nesteruk, Mark Weaver, and Aaron Brooks who leave the area in September. Herb Daniels will chair the meetings until December. LMRA consists of four members.
Status: The LMRA will make an effort to recruit new members by December.
