1. The membership of the Naval Postgraduate School (NPS) Institutional Review Board (IRB) is constituted in accordance with SECNAVINST 3900.39D, 45 CFR 46.107, and 21 CFR 56.107.
2. Members are appointed to serve three years. The IRB Chair and Vice Chair are appointed to serve one year. Reappointment may be recommended to the NPS President in accordance with IRB policies and procedures.
3. Authority to review and make recommendations of all IRB submissions which meet the criteria for expedited or exempt review in accordance with all applicable federal, state, Department of Defense (DOD) and U.S. Navy regulations, guidelines and policies is delegated to the IRB Chair and Vice Chair.
4. All members are required to meet the initial education requirement outlined in the NPS Human Research Protection Program (HRPP) prior to reviewing research. Members are provided with IRB reference materials including applicable DOD, Department of the Navy (DON), federal regulations and NPS IRB and HRPP policies and procedures.
5. A member may resign before the conclusion of his/her term. The IRB Chair has the authority to revoke membership of members who fail to meet his/her responsibilities.
6. Unaffiliated member CPT Richard Brown, USA, resigned from the board. The IRB thanks CPT Brown for his service.
